Driver Selection Guidelines

The safety of the occupants of your vehicles is our primary concern in establishing guidelines for you to use in selecting your drivers. Experienced, safety-conscious drivers are the key to safe vehicle operation and the prevention of accidents. We urge you to select individuals based on maturity, attitude, and safe driving skills. Please follow these guidelines in selecting your drivers:

1. Church Mutual recommends that all drivers be between the ages of 25 and 65. Drivers outside of these recommended age ranges should have clean driving records.
2. Vehicles must be properly equipped if a driver has a license restriction.
3. Drivers having violations such as careless driving, reckless driving, or driving under the influence should not be allowed to operate vehicles on your behalf.
4. All drivers should be properly licensed for the size and type of vehicle being driven. A commercial driver's license is required in certain circumstances.
5. Drivers should have good driving habits. They should not have more than one at-fault accident or one minor traffic violation within the last three years.
